DISSERTATION

I explore the state violence in Texas, involving the Texas Rangers and the US military, against the Mexican-origin communities during the 1910 Mexican Revolution. The purpose of this is to understand how this brutality fit into the continuing process of US state formation during the time of expanding American empire in the early twentieth century. This dissertation will also continue the work of Chicano/a historians to understand how the atrocities during the Mexican Revolution affected and changed the Tejano and Mexican American community in the US and affected US policy toward Latin America.

I scrutinize the underutilized 1919 Canales Papers housed at the Texas State Archives in Austin, the consular documents housed at the MD Anderson Library in Houston, the official US records in Washington D.C., and the records at the Archivo General de la Nación de México and Hemeroteca Nacional de México in Mexico City, Mexico to show how the actions of the Texas Rangers against the Mexican-origin communities demonstrated that the Anglo population in Texas perceived the Tejano/a and Mexican communities as the "other" but also as competitors for the land, resources, and economic space.
