## **CURRENT RESEARCH ACTIVITY**

## Decline of the Euro-American World System

I am currently writing a monograph on societal death and the ultimate fall of the Euro-American world system. That material takes the lectures I have developed for Sociology 206 and uses them as the basis of a book for the general public on realistic crisis models in sociology. Reformulating the Macrobasis of World Systems Theory

World Systems Theory has generally relied on the theory of unequal exchange put forward by Samir Amin to explain how market relations divide the world into core and periphery. The work of Jeffrey Williamson has essentially shattered this foundation by confinement into the periphery was correlated with FAVORABLE rather than adverse terms of trade. The division of the world into core and periphery needs to be reconsidered on a different basis.

I am studying the crystallization of the world into the contemporary split between core and periphery in the last two centuries starting with the rapid ascendance of Australia and New Zealand and concluding with the fall of Argentina. Explicit attention is paid to debt crises (notably those of Austria, Turkey and Egypt), petroleum, educational attainment, protectionism, military Keynesianism, warfare, protectionism and terms of trade. Econometric analysis is being done of 57 nations between 1870 and 1950 along with detailed case studies of the dramatic out-of-period and high leverage cases.

## Women's Economic Power

I am currently working with Rae Blumberg on an edited volume, tentatively titled *Power of the Purse:* Global Causes and Consequences of Women's Access to Economic Resources. We have assembled an all-star list of contributors, including four past or present Presidents of the ASA Development Sociology section, some of the greats in gender and development, such as Valentine Moghadam, and some new rising stars. The goal is to create a completely new paradigm of the determinants of women's economic power.

# Comparative Leontieff Multipliers

I am currently working on a project on the history of Leontieff multipliers for the sectors of capitalist economies from the earliest measurement to the present day. Leontieff multipliers are an indicator of the degree to which particular industries stimulate growth in the rest of an economy. I am analyzing which sectors are strategic and which not and how this changes across time and space.

Eliminating Identification Issues in Macrosocial Cross-National Time-Series Regressions

I am currently at work on a methodological project to correct certain well known statistical errors associated with the use of multiple regression for comparative cross-national time-series datasets. Most of the statistical estimators for such datasets have to correct for various forms of correlated errors. The number of errors is greater than the number of degrees of freedom typically available to allow for the running of regression techniques with "corrections". We put forward a formerly popular but until recently discredited methodology which actually addresses identification issues easily and with efficiency.
